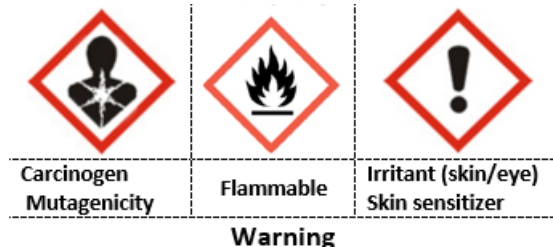

## 2. HAZARDS IDENTIFICATION

This product is a black tape with no odor. Product is not flammable but will burn under fire conditions. May cause mild eye and skin irritation.

<b>HANDLING:</b>	Avoid contact with the eyes and skin. This product is not intended to be heated but if product is heated provide adequate ventilation and avoid breathing vapors and mists. Wash with soap and water after use.
<b>STORAGE:</b>	Store in a cool, well ventilated area away from excessive heat and sources of ignition.

## 8. EXPOSURE CONTROLS/PERSONAL PROTECTION

<b>EXPOSURE GUIDELINES:</b>	Refer to Section 3
<b>ENGINEERING CONTROLS:</b>	General ventilation should be adequate for normal use. For operations where the TLV may be exceeded, mechanical ventilation such as local exhaust may be needed to maintain exposure levels below applicable limits.
<b>RESPIRATORY PROTECTION:</b>	None needed under ambient conditions. For situations where the product is heated, hydrogen sulfide may be released. In such conditions, a NIOSH approved positive pressure self-contained breathing apparatus is recommended. Gas masks or other air purifying respirators are not recommended for hydrogen sulfide due to its poor odor warning properties. Equipment selection depends on containment type and concentration, select in accordance with 29 CFR 1910.134 and good industrial hygiene practice. For firefighting, use self-
